# 1 Summary of Performance

#### 1.A Introduction

This Budget Performance Report for Oyo State is prepared on quarterly basis, and issued within four weeks from the end of each quarter.

This report includes, the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. Quarter 1 performance is assessed against the original 2021 budget. No supplementary or revised budgets have been passed to date in 2021.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23
- Others Economic Account Classes 2203-2207

This Budget Performance Report is produced by the Ministry Budget and Economic Planning and published on the Oyo State website.

#### 1.B Revenue Performance

The total revenue intake for the first quarter 2021 ending March 31 was ₹33, 140,522,142.56 representing 12.3% of the total revenue for the Year 2021 Budget and about half of the target for the first quarter. The State share of Federal Allocation was ₹18, 324, 272, 872.88 resulting in 91.62% on pro-rata basis while the IGR was ₹7, 775, 443, 413.03 accounting for only 30.13% and Capital Receipt was ₹7,040,825,856.65 amounting to 34.74%. Although, there is a deliberate policy to grow the Internally Generated Revenue (IGR) through the Land Use charge and collaboration with Private Sectors, the effects of which, will manifest better in second quarter performance.

#### 1.C Recurrent Expenditure Performance

At the end of first quarter, recurrent expenditure performed at 19.5% against the total recurrent expenditure for the year as stated in 2021 approved Budget. However, on pro rata basis, total recurrent expenditure performed at 77.93% amounting to \$\frac{1}{2}6,964,721,336.30\$. The Personnel Cost together with Consolidated Revenue Fund Charges (CRFC) gulped \$\frac{1}{2}2,334,145,384.92\$ while the Overhead Cost was \$\frac{1}{2}4,630,575,951.38\$.

# 1.D Capital Expenditure Performance

Total expenditure in the 1st quarter was ₩11,748,296,975.33 which fell below the projection of ₩32, 595,319,126.38 for the quarter. This was in part due to the fall in the projected revenue and the need to curtail spending during this period. Notwithstanding the fall in expenditure, a sizeable amount was committed to provision of critical infrastructure to expand the State's economy.

#### Conclusion

The State is committed to implement the budget in line with the provisions of the Oyo State appropriation law and finance act 2021. Priority attention will be given to capital projects with real economic

consequence and the on-going efforts to improve the IGR will be sustained. The Budget Institution will ensure that MDAs comply with budgetary control and guidelines
