1 Summary of Performance

1.A Introduction

This Budget Performance Report for Oyo State is prepared on quarterly basis and issued within four weeks from the end of each quarter. The Budget performance for the Year 2021 stood at about 60% which was an improvement over 50.3% performance recorded in the previous year. On the revenue side, the state's actual aggregate revenue was ₦ 190,590,849,804.73 representing about 59.8% performance against the Year 2021 revised budget. Similarly, the aggregate expenditure was ₦178,052,627,995.90 representing 55.9% performance against the revised Year 2021 budget. It needs to be mentioned that during the year, a supplementary budget of N50, 000,000,000 was duly passed by the State House of Assembly and assented to by the Governor to further provide three critical infrastructures namely, Ibadan Circular Road project (₦25b), Iseyin-Ogbomoso Road (₦15b) and Rehabilitation and Upgrade of Ibadan Airport (₦10b). Unfortunately, these projects could not materialize due to inability of the supporting financial institution to provide the required loan. Consequently, the supplementary budget increased the original budget from ₦268,770,964,860.01 to the final budget of ₦318,770,964,860.01.

This report includes the final budget appropriation for the year 2021 in respect of each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q4, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. The Final Budget of N318.8 billion on which the performance for the year was measured consists of original budget (N268.8 billion) and supplementary budget of (N50 billion) which was passed in August 2021 and also presented.

The core economic classifications refer to:

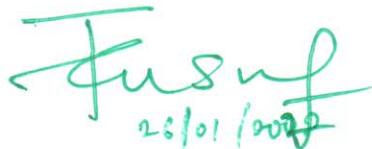
- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23
- Others - Economic Account Classes 2203-2207

This Budget Performance Report is produced by the Ministry Budget and Economic Planning and published on the Oyo State website.

1.B Revenue Performance

The total revenue intake for the fourth quarter 2021 ending December 31 was ₦22,597,938,514.05 representing 12.3% of the expected total revenue for the Year 2021 Revised Budget and 55.3% cumulative performance against 2021 Revised budget. The State share of Federal Allocation was ₦ 14,431,509,293.46 resulting in 72.2% performance on pro-rata basis while the IGR was ₦ 8,166,429,220.59 accounting for only 31.6% which is marginally below the 32.3% recorded in the previous quarter. Capital Receipt experienced a quantum leap from ₦17,399,682,559.74 in quarter 3 to ₦44,924,910,678.23 in quarter 4 representing about 158.2% increase. Generally, it is discernible from the above analysis that the Capital receipt contributes largest chunk of the State revenue profile. However, there is a deliberate policy to reverse the ugly trend through aggressive expansion of the economy which will positively improve Internally Generated Revenue (IGR). Already, the State has embarked on expansion of her tax base to bring more people in the informal sectors into tax net apart from blockage of observed revenue leakage and integration tax automated system.

The State share of VAT was about ₦10,273,737,416.55 for the fourth quarter while aggregate for the year was ₦39,688,595,260.44 representing 158.8% performance. This is so as the recently released figures by NBS indicated that the State's contributions to Nigeria's Value Added Tax shot up to over N64 Billion in eight months

By and large, the overall revenue for the year was ₦ 190,590,849,804.73 including opening balance representing about 59.8% performance against the Year 2021 revised budget.

1.C Recurrent Expenditure Performance

At the end of fourth quarter, recurrent expenditure performed at 23.9% against the total recurrent expenditure for the year 2021 revised Budget. However, on pro rata basis, total recurrent expenditure stood at 95.7% amounting to ₦33,109,604,590.89 thereby improving cumulative performance for the year to 83.8% against the Year 2021 revised budget. The Personnel Cost gulped ₦ 23,649,603,262.66 while the Overhead Cost was ₦ 8,809,553,563.40.

1.D Capital Expenditure Performance

Total capital expenditure in the fourth quarter was ₦ 27,014,838,919.32 which fell below the projection of ₦45,095,319,126.38 for the quarter. This was in part due to the fall in the projected revenue especially the much-anticipated capital loan that is yet to be finalized and the need to invest more on human capital development to reduce poverty and vulnerability in the State.

In the year under reference, about ₦62,051,951,149.29 was committed to the provision of critical infrastructure. The State recorded giant strides in the development of critical infrastructure which was believed would generate more income for the state in the coming years. For instance, the State completed rehabilitation and upgrade of 40 Primary health care facilities, the Challenge Bus Terminal was 70% complete, while the other three terminals at Iwo Road, New Ife Road and Ojoo are ongoing. The Fasola Agribusiness Industrial Hub is at about 40% completion. Significant progress has also been made in reconstructing the 21km Airport- Ajia-New Ife Express Road with a spur to Amuloko, 12km Apete-Awotan-Akufo Road and the 44.7km Saki-Ogbooro-Igboho Road. The Idi Ape-Basorun-Akobo- Odogbo Barracks Road and the 5.2km Gedu-Oroki-Sabo-Asipa Road are nearing completion while the light-up project of about 110km is 85% completed. The explained why some MDAs recorded zero performance.

In the final analysis, the total expenditure for the year stood at ₦178,052,627,995.90 representing 55.9% performance against the revised Year 2021 budget.

Conclusion

Going forward, the State is prepared to proactively improve budget performance to about 75% as contained in the Year 2022 budget speech of the Executive Governor. Priority attention will be accorded to capital projects with real impact on the State economy and the on-going efforts to improve the IGR will be sustained especially through expansion of tax base to include more people in the informal sector into tax net. The Budget Institution will also ensure that MDAs comply with budgetary control guidelines and the provisions of the appropriation law.

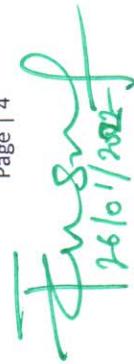

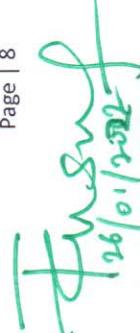
