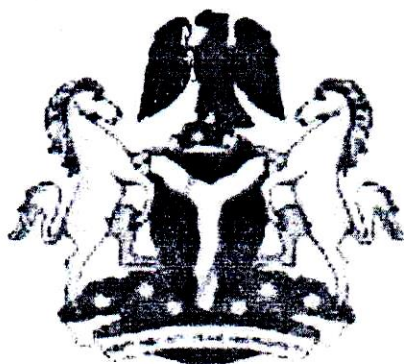
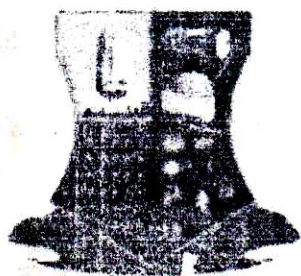

BASIS OF ACCOUNTING

The Financial Statements are prepared under the historical cost convention. The accrual basis of accounting which reflects all expenses whether paid or not and all income whether received or not, from the basis for the preparation of Financial Statement as obtained in all public accounting treatment.

CAPITAL EXPENDITURE:

The capital expenditure captured all payment made and those that are yet to be paid.

FIXED ASSET: Fixed Assets are stated at cost less provision for Depreciation.

INVESTMENT: Investment are stated at cost with provision for diminution in value of such investment.

ADVANCES:

Represents the balance in the account of individual staff in respect of Vehicle Refurbishing Loan to the establishment staff.

DEPOSIT:

The deposit represents the Local Government indebtedness to other Local Government in the State in form of deduction made from salaries of staffs in respect of loan brought from such Local Government on transfer which Local Government has not remitted to such Local Government.


