Process of obtaining Professional/Business Premises Registration certificate in Oyo State through the Ministry of Trade, Industry, Investment and Cooperatives, Secretariat, Ibadan.

Professional/Business Premises Laws:

The Laws of Oyo State of Nigeria containing the law of the state in force on the 31st day of march 2000 as state laws and certain other laws made after that date together with certain

SUBSIDIARY LEGISLATION MADE THEREUNDER and certain FEDERAL ACTS AND DECREES

A Law to make Provision for the Registration of Business and Professional Premises and for other Matters Incidental Thereto or Connected Therewith.

- 1. This Law may be cited as the Business and Professional Premises (Registration) Law.
- 2. in this law, unless the context otherwise requires:

"Business" has the meaning assigned to it in the Business Premise (Rent Control) Law;

"Commissioner" means the State Commissioner responsible for Commerce and Industry;

"Court" includes the High Court or Magistrate's Court but does not include customary court;

"functions" includes power and duties;

"Ministry" means the State Ministry of Commerce and Industry;

"the Permanent Secretary means Permanent Secretary of the State's Ministry of Commerce and Industry;

- **3.** (1) no person shall carry on any business unless the business or professional premises has been duly registered by the ministry.
- (2) application for the registration of any business of professional premises shall be made to the Permanent Secretary in the form prescribed in the First

Schedule hereto and shall be accompanied with a receipt for the appropriate sum specified in the second column of the Second Schedule hereto issued by the nearest State Government Treasury and the applicants tax clearance certificate for the last three years.

- (3) on receipt of such application and on being satisfied that all other conditions for the establishment of such a business in the premises have been satisfied, the Permanent Secretary shall issue to the applicant a certificate of registration in the form prescribed in the Third Schedule hereto.
- (4) subject to the provision 5 of this law, the registration of a business shall be renewed annually upon the production of a receipt for sum specified in the Third column of the Second Schedule hereto issued by the nearest State Government Treasury and the applicants tax clearance certificate for the last three years.

Inspection of premises

4. It shall be lawful for the Permanent Secretary or any officer authorized by him in writing to enter any building or premises being used as business or professional premises at all or reasonable times for the purpose of inspection of such building or premises in order to ascertain compliance with the provisions of this Law.

power to seal off a business or professional premises

- 4a (1) Notwithstanding the provision of the law, it shall be lawful for the Permanent Secretary or any officer authorized by him in writing, with the assistance of the Commissioner of Police of the State or his representative, to seal off any business or professional premises whose proprietor evades or refuses to pay the appropriate registration fee.
- (2) it shall be unlawful for the proprietor, his servant or agent to transact any business or remove the seal until the proprietor registration fee is paid or the seal is removed by the Permanent Secretary or any officer authorized by him".

power to suspend or cancel registration

5. Where it appears to the Permanent Secretary or any officer authorized by him in writing, that the provision of this law are not being complied with, he may by order in writing addressed to the proprietor or to the person for the time being in charge or appearing to be in charge thereof suspend or cancel the registration of such premises.
