1 Summary of Performance

1.A Introduction

This Budget Performance Report for Oyo State is prepared on quarterly basis and issued within four weeks from the end of each quarter. The Budget performance for the Quarter 1 of the Year 2022, ought to have performed at 25% but stood at about 20.4% which was an improvement over 13.5% performance recorded in the previous year. On the revenue side, the state's actual revenue for the quarter was ₦60,013,044,904.60 representing about 20.4% performance against the Year 2022 original budget. Similarly, the expenditure was ₦56,741,747,401.51 representing 19.3% performance against the original Year 2022 budget.

This report includes, the original approved budget and appropriation for the year 2022 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2022 Original Budget

The core economic classifications refer to:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23 / 32
- Others - Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Ministry of Budget and Economic Planning, and published on the 2022 State website.

1.B Revenue Performance

The total revenue ought to have performed at 25%, by the end of the first quarter rather it performed at 20.4% the intake was ₦60,013,044,904.60 of the expected total revenue for the Year 2022 Original Budget. The State share of Federal Allocation was ₦ 20,474,809,459.65 resulting in 34.1% performance on the total actual revenue, IGR was ₦9,566,450,538.58 accounting for only 15.9% which is marginally increase of 18.72% compared to the same quarter previous year. Capital Receipt performed at ₦ 26,793,526,408.37 representing 44.6% . Generally, it is discernible from the above analysis that the Capital receipt contributes largest chunk of the State revenue profile. However, there is a deliberate policy to reverse the ugly trend through aggressive expansion of the economy which will positively improve Internally Generated Revenue (IGR). Already, the State has embarked on expansion of her tax base to bring more people in the informal sectors into tax net apart from blockage of observed revenue leakage and integration tax automated system.

1.C Recurrent Expenditure Performance

By the end of the first quarter, Expenditure ought to have performed at 25% but rather it performed at 19.3% of the total expenditure of ₦ 56,741,747,401.51, total recurrent expenditure is ₦31,896,412,415.80 which represent 56.22% of the total expenditure, out of which Personnel gulped the sum of ₦22,153,792,259.53 representing 69.44% while Other recurrent cost gulped the sum of ₦ 9,742,620,156.27 representing 30.56%

1.D Capital Expenditure Performance

Capital Expenditure performance during the first quarter stood at ₦ 24,845,334,985.75 representing 43.78% of the total expenditure performance out of the capital expenditure performance, Ministry of Public Works & Transportation expended the sum of ₦ 22,153,792,259.53 representing 89.16%. This was as a result of payment for completion project such as the Bus Terminals, part payment of Circular road, Iseyin -Ogbomosho road, and some other road construction across the State.

1.E Conclusions

Going forward, the State is prepared to proactively improve budget performance to about 75% as contained in the Year 2022 budget speech of the Executive Governor. Priority attention will be accorded to capital projects with real impact on the State economy and the on-going efforts to improve the IGR will be sustained especially through expansion of tax base to include more people in the informal sector into tax net. The Budget Institution will also ensure that MDAs comply with budgetary control guidelines and the provisions of the appropriation law.
